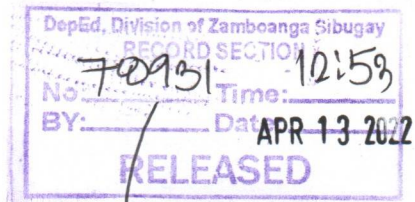

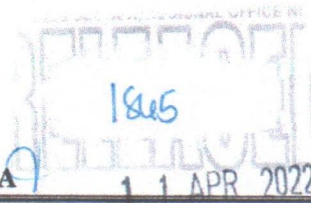

d. Must be computer literate and have access to stable Internet connection to enable them to participate in online interactions.	4. Endorsements from the head of office
e. Able and willing to utilize course learning as well as share them with other upon completion of the program.	a. endorsement from the Schools Division Office through the Office of the SDS
f. Must hold a permanent appointment at the organization nominating him/her	b. Nomination Letter from the Regional/Bureau Director or his/her duly authorized representative (thru the Regional HRDD Chiefs)
g. Must have no pending administrative and/or criminal case	
h. Must have a college degree and/or sufficient demonstrated ability and experience related/relevant to the course he/she is applying for	
i. Must have a good command of the English language (spoken and written)	
j. Must have professional development needs aligned with the KRAs of the organization.	
k. Must have outstanding accomplishments related/leading to the program applying for	
l. Must have no pending nomination for scholarship in another program/course or have already rendered the required service obligation for a scholarship previously enjoyed	
m. Physically and mentally fit
