
12TH WESTERN MINDANAO REGIONAL SCOUT JAMBOREE

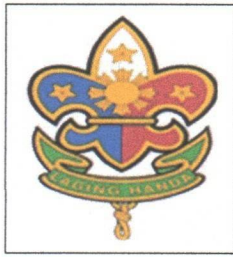

SUBJECT : 12TH WM REGIONAL SCOUT JAMBOREE

1. Boy Scouts of the Philippines Western Mindanao Region is happy to announce the conduct of the **12th Western Mindanao Regional Scout Jamboree on 23-27 AUGUST 2024** to be held at Municipality of Leon B. Postigo, Zamboanga del Norte with the **Theme: "Sustaining Growth"**.
2. The 12th WMR Regional Scouts Jamboree aims to provide exciting, challenging safe and enjoyable learning activities for the Scouts in order to enhance their full Social, Physical, Intellectual, Character, Emotional and Spiritual potentials as an active citizen making real contribution in creating a better community.
3. **Qualifications:**
 - a. Participating scouts must a:
 - Must be currently registered as Scout.
 - Must be Physically fit to undergo strenuous activities especially in the outdoors as certified by a licensed Physician.
 - Must be nine (9) to twelve (12) years old for Boy Scouts
 - Must be at least thirteen (13) to nineteen (19) years old for Senior Scouts;
 - Secure his/her Parent's/Guardian's Consent; and
 - Must have his/her own camping gears and equipment.
 - b. Troop Leader and Outfit Advisor
 - Must be of good moral character;
 - Must be currently registered as an Adult Leader
 - Must be Physically fit as certified by a licensed Physician;
 - Must be a graduate of Basic Training Course
 - Must have his/her own camping gears and equipment;
 - Must have undertaken an online introduction course from WOSM's Safe From Harm thru this link <https://www.scout.org/what-we-do/member-organizations/child-and-youth-safety>

4. **Participation Ratio.** To exercise effective and efficient unit organization and management, a ratio of One (1) Adult Leader for every nine (9) Scouts (1:9) must be observed in the composition of the Jamboree Contingent.
5. **Registration Details.** Stated below are the important details regarding the Jamboree Registration System and procedure, viz:
- a. Registration: A Jamboree fee of **FIVE HUNDRED PESOS (Php 500.00)** shall be charged from each participant in order to defray administrative cost, program materials, souvenir items and other operating expenses.
 - b. Jamboree Registration Fee must be deposited directly to the Depository Bank Account of the host Council. Account Details stated below:

 - c. The 12th WMRSJ Roster of participants (please see attached) together with the Deposit Slip must be submitted to the host council at dv8bqi@yahoo.com copy furnish Regional Office via email at wmrco@scouts.gov.ph.
6. **Food Provision:** Participating contingents must provide for their own food and other basic requirements that will be sufficient throughout the entire duration of the Jamboree. Each contingent is responsible in managing their respective kitchens, mess and commissaries. Wet and Dry Markets will be made available at the Jamboree Site in order to ensure availability of food supplies at reasonable prices.
7. **Transportation and Equipment:** Each contingent shall be responsible in arranging their own transportation to and from the jamboree site.
8. All concerned are hereby enjoined to promote and help ensure the maximum participation of the Scouts and Adult Leaders with in your respective Institution and Districts. You are further advised to organized working committees in order to support your respective Contingent Management Team (CMT's) to ensure the efficient preparation for the events and the smooth relay information and other details.
