- 1. Pursuant to the letter sent by the Branch Head of the PAG-IBIG Fund Pagadian Branch, all personnel of the Schools Division of Zamboanga Sibugay may now avail of the PAG-IBIG Loyalty Card Plus.
- 2. This Loyalty Card Plus serves as a PAG-IBIG Transaction Card and can be used as one of the basic requirements and acceptable identification in applying for Multi-Purpose Loan (MPL), Housing Loan (HL) and Provident Benefits Claim. It also provides discounts on medicine, tuition-fee, travel, beauty and wellness services, reward benefits on groceries and fuel through PAG-IBIG Fund's partner establishments.
- 3. Anent this, all Administrative Officers II are directed to submit the filled-out Loyalty Card Plus Enrolment Kiosk Form to the Personnel Section to secure the enrolment schedule for the District personnel before collecting the Loyalty Card Plus Fee from each personnel during the onsite enrolment.
- 4. All Permanent and Casual Personnel of this Division may fill out the attached Loyalty Card Plus Application Form (HQP-PFF-108) which is downloadable through pagibigfund.gov.ph or bit.ly/depedzspersonnel
- 5. Administrative Officers designated as focal in the district shall consolidate all filled-out forms and shall submit to the Office of the Personnel Section on or before July 15, 2024.
- 6. Immediate and widest dissemination of this memorandum is highly enjoined.
