- 1. In relation to DepEd's implementation of the Teacher Induction Program (TIP) through DepEd Order No. 43, s. 2017, to support new teachers to their first years of teaching by way of contributing to their sense of well-being and professional development (Partlow, 2006), the TIP aims to assist beginning teachers in adapting to the standards and requirements of the profession, aligned with the Philippine Professional Standards for Teachers (PPST).
- 2. To immerse beginning teachers in the processes and systems of the public schools, and enhance their teaching practice, they were provided with self-learning coursebooks they have to complete in one (1) year.
- 3. In response to the rapid digital evolution and advancements in education considering continuous improvement, the SGOD-Human Resource Development (HRD) section developed a comprehensive portfolio system in collaboration with ICT for managing the IPBT utilizing information technology ensuring efficient tracking, managing, and enhancing the IPBT process.
- 4. In this regard, an IPBT Tracking System user acceptance testing will be done on **10 September 2024** (Tuesday), **9:00 am** at the ICT Office.
