

1. With reference to DepEd Order No. 13, s. 2024 titled "Administration of the FY 2023 NQESH," Item 7 states that:

"FY 2021 NQESH Takers who belong to category B shall no longer take the examination. Upon completion of their coaching and mentoring sessions, they will undergo an evaluation and certification process by the National Educators Academy of the Philippines (NEAP)."

- 2. In view of this, the FY 2021 NQESH Category B, who completed coaching and mentoring certified by their respective Regional Directors, shall undergo the evaluation and certification process on **28 September 2024.** Cluster 4 including Region IX with 152 participants, will have its venue at Cebu City.
- 3. FY 2021 NQESH Category B candidates are advised to be at their respective venues on 27 September 2024 at 3:00 o'clock in the afternoon. Details regarding accommodation and meal provisions is provided in the attached memorandum.
- 4. Participants are encouraged to register through this link https://tinyurl.com/2021CatB-RegExAssess for confirmation of attendance and participation in the evaluation and certification on or before 15 September 2024, 5:00 o'clock in the afternoon.
- 5. Furthermore, a separate memorandum shall be issued for the identified RO and SDO personnel who will serve as members of the program management group and will work closely with the central office personnel.
- 6. Accommodation and travel expenses of candidates and members of the PMT across governance levels shall be charged against NEAP-HRD Funds. Transportation, per diem and other incidental expenses of candidates shall be charged against SDO local funds subject to the usual accounting and auditing rules and regulations.
