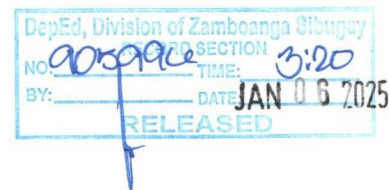

REITERATION OF DIVISION MEMORANDUM NO. 524 s. 2024

1. This is in reference to Division Memorandum No. 524 s. 2024 regarding the Conduct of the 2025 Schools Press Conference and Campus Journalism Activities. The **Division Schools Press Conference (DSPC)** will take place from **January 8 to 10, 2025**, at Diplahan National High School in Diplahan, Zamboanga Sibugay. The last day of the DSPC will be focused on enhancement sessions for the DSPC winners, in preparation for the RSPC scheduled on February 2025.

2. The participants/qualifiers eligible for the DSPC are the following:

Table 1. DSPC Participants/Qualifiers

Individual Categories	Top 5 Congressional District winners per medium, per level
Group Categories	3 teams per medium (Composed of 7 members each team) except for Online Collaborative and Desktop Publishing (5 members each team)

3. Furthermore, the Top 3 DSPC winners in individual categories, per medium and per level, along with one (1) team per medium in the group categories (composed of 7 members each, except for Online Collaborative and Desktop Publishing, which consist of 5 members each), will qualify for the Regional Schools Press Conference.

4. All participating schools in the DSPC must have a school paper published in a PDF or digital format of at least 12 pages, which should include the following sections: news, editorial, feature, science and technology, and sports. No campus journalist will be allowed to join the competition without the complete sections of the paper. The school publications must be from the School Year 2024-2025. Previous print and PDF publications will not be considered eligible for entry into the competition.
