
CONDUCT OF BRIEF COMPUTER ASSESSMENT FOR GRADES 4,5,6, JHS AND SHS LEARNERS

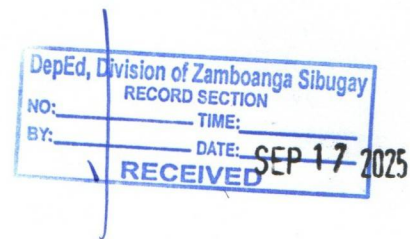
