REITERATION ON THE ADOPTION AND IMPLEMENTATION OF SCHOOL MOOE WEB-BASED MONITORING SYSTEM CUM ORIENTATION ON THE OBLIGATION TO WITHHOLD TAXES ON PURCHASE OF GOODS AND SERVICES

To: Public Schools District Supervisors/Districts-In-Charge All Elementary and Secondary School Heads All District & School Administrative Officers II All Elementary & Secondary ADAS II & III All Others Concerned This Division

- 1. In reference to Division Memorandum No. 460, s. 2024, dated October 25, 2024, titled "Orientation on the Adoption and Implementation of School Maintenance and Other Operating Expenses (MOOE) Web-Based Monitoring System" and Division Memorandum No. 528, s. 2024, dated December 9, 2024, titled "Implementation of Obligation to Withhold Taxes on Purchases of Goods & Services", this office hereby directs all schools to fully adopt & implement the MOOE web-based monitoring system as well as the deduction/withholding taxes on its purchases of goods and services.
- 2. This reiteration seeks to rectify the inaccuracies in utilizing the MOOE web-based system and to facilitate a comprehensive understanding of its operational mechanisms. Furthermore, it encompasses orientation on the procedural implementation of tax withholding for the acquisition of goods and services, which will also be administered through the system.
