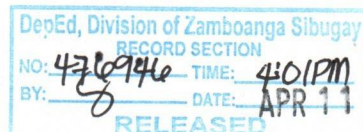

**REITERATION IN THE ESTABLISHMENT, ACTIVATION OF SCHOOL GOVERNANCE COUNCIL (SGC), AND RECONSTITUTION OF THE DIVISION OFFICE SGC COMPOSITE TEAM**

1. Pursuant to DepEd Order No. 026, s. 2022, titled "Implementing Guidelines on the Establishment of the School Governance Council (SGC)," the DepEd Schools Division Office of Zamboanga Sibugay reiterates the directive for the establishment and activation of School Governance Councils (SGCs) at both the elementary and secondary levels. These councils shall serve as the overall coordinating body for all school committees and organizations, helping to operationalize the principle of shared governance as mandated by Republic Act No. 9155. This initiative also supports the strengthening of School-Based Management (SBM) in all schools.
2. Additionally, per DM-OUHROD-2022-0090, dated October 6, 2022, schools are encouraged to establish a Composite Team for the validation of the School Governance Council Functionality Assessment Tool (SGC-FAT) for both elementary and secondary levels.
3. In line with this, the Schools Division Office, through the School Governance and Operations Division (SGOD) and the School Management, Monitoring and Evaluation (SMME) Section, hereby reconstitutes the Division SGC Composite Team as follows:
