#### ADOPTION OF DEPED ORDER NO. 004, SERIES OF 2025

To: Assistant Schools Division Superintendent Chief Education Supervisors

Administrative Officer V

Public Schools District Supervisors

School Heads

All Others Concerned

- 1. Relative to D.O. 004 s. 2025 on the *Guidelines on the Adoption of the Flexible Work Arrangement in the Department of Education*, this Division issues this memorandum to adopt the provisions of the same;
- 2. All non-teaching and related-teaching officials and employees within this Division are granted the privilege to adopt this **Flexible Work Arrangements (FWA)**, provided that the weekly working hours shall not be reduced to 40 hours per week, exclusive of time for lunch:
  - a. Flexitime (either Full Flexitime or Fixed Flexitime)
  - b. Skeleton Workforce\*\*
  - c. Work-From-Home\*\*
  - d. Combination of Flexible Work Arrangements
  - \*\*These work arrangements may only be availed of when full staffing is not possible during emergency cases; and for employees under extreme medical and situational conditions.
- 3. DepEd personnel under any FWA are required to attend the flag raising ceremony at exactly 8:00a.m. of every Monday as provided in Republic Act No. 8491;
- 4. DepEd officials and employees may apply to any FWA through their respective Heads of functional offices, who will prepare a **Summary of Personnel Under Flexible Work Arrangement**<sup>1</sup>, which will then be submitted to the Head of Office for approval, as follows:

- 5. The approved request of the respective offices shall be submitted to the Personnel Section of this Division not later than the fourth week of the preceding month for monitoring and recording purposes;
- 6. Immediate heads are mandated to:
  - a. Ensure the compliance of all conditions set forth under D.O. 004 s. 2025;

- b. Ensure that there are available personnel during normal working hours between 8:00-5:00p.m. to cater clientele of the schools/office;
- c. Ensure equal distribution of the work arrangements of DepEd personnel; and
- d. Ensure that the lunch break time of 60 minutes (or 1 hour) for all employees should not be reduced and should be excluded from the counting of the daily 8 working hours.
- 7. Further, those who fail to observe the eight-hour workday through consistent tardiness, undertime, and loafing from duty during office hours may be administratively charged and penalized with suspension or dismissal from service under civil service law, rules, regulations, and D.O. 4, s. 2006;
- 8. This issuance shall take effect immediately after its publication;
- 9. For your information, guidance, and dissemination.
