INTERFACE MEETING ON THE ALIGNMENT AND INTEGRATION OF SCHOOL-BASED MANAGEMENT (SBM), PERFORMANCE MANAGEMENT AND EVALUATION SYSTEMS (PMES), AND BASIC EDUCATION DEVELOPMENT PLAN (BEDP) 2030 PERFORMANCE INDICATORS (PHASE I)

- 1. In pursuit of enhancing the coherence and effectiveness of school operations and instructional delivery, it is imperative that SGOD and CID engage in a collaborative interface. The objective of this engagement is to examine the alignment and interconnectedness of the revised **School-Based Management** (SBM) System as outlined in **DepEd Order No. 007,s.2024**, the **Performance Management and Evaluation System (PMES)**, and the integration of performance indicators as stipulated in **DepEd Order No. 024**, **s. 2022** (Adoption of the Basic Education Development Plan (BEDP) 2030) and as stated in a **Memorandum DM-OUHROD-2025-0922**. This interface will also address the use and **harmonization of monitoring tools**, whether customized or standardized.
- 2. Specifically, this interface aims to:
 - Review and align the revised SBM System and PMES with the performance indicators of BEDP 2030;
 - b) Ensure that monitoring tools are integrated and supportive of unified goals;
 - c) Promote a shared understanding among functional divisions regarding the interconnectedness of these systems, guidelines, and processes; and
 - d) Provide clear guidance to schools, ensuring that these systems are seen as relevant, significant, and mutually reinforcing rather than isolated or fragmented.
- 3. Through this collaborative engagement, SGOD and CID are expected to develop a unified approach and provide coherent guidance and support to schools as implementers. This will help schools recognize the relevance and significance of these systems and prevent them from being perceived as separate or disconnected processes.
