- 1. In relevance to Regional Memorandum No. 261 S, 2025 on the Implementation of the Phase-2 revised K to 12 Curriculum Capacity Building for Grades 2, 3, 5, and 8, this division will commence the School-Based Training for Teachers, as part of the preparation of implementing the curriculum for SY 2025-2026.
