#### SUBMISSION OF THE ENHANCED 2025 ANNUAL IMPLEMENTATION PLAN

To: Assistant Schools Division Superintendent Chiefs of SGOD and CID All Section Heads All Others Concerned This Division

- 1. The recently concluded 1st Quarter Program Implementation Review (PIR), held on April 10-11, 2025, provided substantial insights into the implementation progress of the FY 2025 Annual Implementation Plan (AIP) across the three functional divisions. The PIR emphasized areas requiring updates and adjustments to address current challenges and further align with performance targets.
- 2. In light of the observations shared during the PIR and the identified areas of improvement in the submitted 2025 AIPs, all section heads are instructed to revisit their respective AIPs. As agreed during the PIR, updates or necessary adjustments must be incorporated by April 30, 2025.
- 3. When revising the AIPs, all section heads are reminded to incorporate the following elements:
  - 3.1 PPAs associated with PREXC indicators (if applicable to their sections).
  - 3.2 PPAs of non-PREXC indicators as defined by the Regional Office.
  - 3.3 PPAs with Program Support Funds (PSFs) to ensure comprehensive alignment with funding and performance targets.


