**TRAINING OF ATHLETES FOR THE REGIONAL MUSIC, ARTS, PHYSICAL  
 EDUCATION AND HEALTH (MAPEH) CULMINATION PROGRAM CUM  
 ZAMBOANGA PENINSULA REGIONAL ATHLETIC ASSOCIATION  
 (ZPRAA) MEET 2026**

1. In preparation for the participation of Zamboanga Sibugay Athletic Association (ZSAA) in the forthcoming MAPEH Culmination Program cum Zamboanga Peninsula Regional Athletic Association (ZPRAA) Meet 2026 on April 6-11, 2026 in Isabela City, all coaches are advised to resume the training of their athletes from March 2-31, 2026.
2. All athletes of the team events shall go back to their respective club for their training, while athletes of the individual/measured events and those who are from other sports club/school may temporarily be accommodated by the winning school adopting alternative delivery mode using modules to ensure continuity of learning.
3. Proper arrangement with parents, class advisers and school principal must be done to ensure primarily the safety and welfare of the learner-athletes.
4. While it is effective to have a group training, individual training is also encouraged to instill in the minds of the athletes that winning the game is not just the team's desire but also of the individual's aspiration.
5. Coaches and athletes are always reminded that safety is our priority.
6. Travel, meals and snacks and other expenses relative to the conduct of the training can be charged against local funds/MOOE of the schools and other sources of funds the club has subject to its availability and to the government accounting and auditing rules and regulations if necessary.
