ADMINISTRATION OF 2025 ACCREDITATION AND EQUIVALENCY (A&E) TEST

1. The **Department of Education, Division of Zamboanga Sibugay**, through the School Governance and Operations Division – Monitoring and Evaluation (SMM&E) and in coordination with the Curriculum Implementation Division (CID), announces the administration of the **2025 Accreditation and Equivalency (A&E) Test**. The examination will take place on **March 29, 2026**, across eight designated testing centers.
2. To ensure a seamless examination process, all designated testing personnel—including **Supervising Examiners, Chief Examiners, and Room Examiners**—are directed to:
 - a. Conduct a thorough **ocular inspection** of their respective venues before the test schedule
 - b. Ensure all testing rooms are **conducive to assessment**, well-ventilated, and properly prepared ahead of the examination date.
3. A monitoring team composed of representatives from the **Central Office (BEA)**, the **Regional Office**, and the **Division Testing Coordinator** to supervise the administration and ensure compliance with national testing standards.
4. The implementation timeline for the 2025 A&E Test is detailed below. **All testing personnel are strictly reminded to adhere to these schedules** to maintain the integrity and efficiency of the process.
