- 3 WHEREAS, the Schools Division Superintendent has approved "SMALL VALUE PROCUREMENT", as the particular mode of procurement per recommendation of the Bids and Awards Committee;
- 4 WHEREAS, the conditions and/or requirements for "SMALL VALUE PROCUREMENT" under Section 52 of the IRR has been met and/or complied with;
- 5 WHEREAS, an opening of bids was conducted on **November 5, 2024** at the Division Office by the Chair & Members of the Division Bids & Awards Committee;

- 6 WHEREAS, the Bids and Awards Committee, through its Secretariat, has received price quotations submitted by the following bona fide suppliers of known qualifications, to wit:


