- 1 WHEREAS, RA 9184 provides for the modernization, standardization, and regulation of the procurement activities in the Government;
- 2 WHEREAS, with the prior approval of the Schools Division Superintendent, as the head of procuring entity in the Department of Education, Division of Zamboanga Sibugay may, whenever justified by the conditions provided for in R.A. 9184, resort to any of the alternative modes of procurement provided for in the Implementing Rules & Regulations (IRR) of R.A. 9184
- 3 WHEREAS, the Schools Division Superintendent has approved "SMALL VALUE PROCUREMENT", as the particular mode of procurement per recommendation of the Bids and Awards Committee;
- 4 WHEREAS, the conditions and/or requirements for "SMALL VALUE PROCUREMENT" under Section 52 of the IRR has been met and/or complied with;
- 5 WHEREAS, an opening of bids was conducted on **November 12, 2024** at the Division Office by the Chair & Members of the Division Bids & Awards Committee;
- 6 WHEREAS, the Bids and Awards Committee, through its Secretariat, has received price quotations submitted by the following bona fide suppliers of known qualifications, to wit:

- 7 WHEREAS, during the conduct of bid opening it was found-out that the supplier with the lowest bid offer was **3U'S CONSUMER GOODS TRADING** and **GALAXY ENTERPRISES**.
- 8 WHEREAS, after careful evaluation of the bids submitted by the aforesaid suppliers, the Bids and Awards Committee found out that **3U'S CONSUMER GOODS TR** lacks the specific line of business in their respective Business Permit needed for the delivery of the goods required for this procurement as attached herein.
- 9 WHEREAS, **GALAXY ENTERPRISES** failed to submit their eligibility documents to support their bid.
- 8 WHEREAS, after careful evaluation of the bids submitted by the aforesaid suppliers, the Bids and Awards Committee found out that the 2nd lowest bidder **IPIL PRINTHAUS** is the most compliant and has the necessary line of business needed for the procurement of plaques as attached herein.
- 8 NOW THEREFORE, RESOLVED, as it is hereby RESOLVED, pursuant to Section 12 of R.A. 9184 and the applicable provisions of its IRR, to award the bid to **IPIL PRINTHAUS** on **November 13, 2024**
