1 WHEREAS, RA 9184 provides for the modernization, standardization, and regulation of the procurement activities in the Government;

2 WHEREAS, with the prior approval of the Schools Division Superintendent, as the head of procuring entity in the Department of Education, Division of Zamboanga Sibugay may, whenever justified by the conditions provided for in R.A. 9184, resort to any of the alternative modes of procurement provided for in the Implementing Rules & Regulations (IRR) of R.A. 9184

3 WHEREAS, the Schools Division Superintendent has approved "SMALL VALUE PROCUREMENT", as the particular mode of procurement per recommendation of the Bids and Awards Committee;

4 WHEREAS, the conditions and/or requirements for "SMALL VALUE PROCUREMENT" under Section 52 of the IRR has been met and/or complied with;

5 WHEREAS, an opening of bids was conducted on **February 20, 2026** at the Division Office by the Chair & Members of the Division Bids & Awards Committee;

6 WHEREAS, the Bids and Awards Committee, through its Secretariat, has received price quotations submitted by the following bona fide suppliers of known qualifications, to wit:
