4. FEES AND BILLING SCHEDULE

4.1. For and in consideration of all the foregoing services, as well as compliance by the **CONTRACTOR** of all the terms and condition of this Contract, the **SCHOOLS DIVISION** shall pay a total amount of **Five Million Forty-Nine Thousand One Hundred Pesos (Php5,049,100.00)**, Philippine currency, inclusive of any and all taxes (including, but not limited to, the applicable Value Added Tax), fees, duties and such other imposts or levies which may be required by the government, both national and local.

4.2. Payment of said fees shall be made by the **SCHOOLS DIVISION** upon completion of delivery of items;

4.3. All payments shall be subject to the usual accounting and auditing rules and regulations.

5. LIQUIDATED DAMAGES

a. Liquidated damages shall be charged against the **CONTRACTOR** amounting to at one-tenth of one percent (0.001) of the cost of the unperformed portion for every day of delay.


b. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.


6. DURATION

5.1. This **CONTRACT** shall be completed based on the schedule provided, reckoned from the date of acceptance of the Notice to Proceed from the **SCHOOLS DIVISION** by the **CONTRACTOR**.
