7 WHEREAS, after careful evaluation of the bids submitted by the aforesaid suppliers, the Bids and Awards Committee found out that


EL RONIES CAFE as the most compliant and have offered the most advantageous price to the Department of Education, Division of Zamboanga Sibugay.
