5 WHEREAS, an opening of bids was conducted on **September 2, 2024** at the Division Office by the Chair & Members of the Division Bids & Awards Committee;




Purpose **Seminar-Workshop on Pre-Retirement Innovation and Options for Results (PRIOR) on October 2-4, 2024.**
