#### Description

1.The Department of Education-Division of Zamboanga Sibugay intends to procure 2700 units of Mobile Tablets to Learners as Supplementary Learning Resources with Digitized Supplementary Learning Materials for JHS & SHS -Lot 4 with the Approved Budget for the Contract (ABC) of Forty Million Four Hundred Seventy-Three Thousand (Php40,473,000.00).

2.The DEPED-Division of Zamboanga Sibugay, through its Bids and Awards Committee (BAC), now invites technically, legally, and financially capable suppliers for the said Mobile Tablets.

3.The procurement procedure for this requirement is Negotiated Procurement under Two-Failed Biddings pursuant to Section 53.1 of the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act", including Annex H thereof using non-discretionary pass/fail criteria.

The BAC will engage in negotiations with at least three (3) suppliers who are technically, legally, and financially capable to ensure effective competition (Annex H of RA 9184). The selection of the successful offer shall be based on the best and final offer that will be submitted on the specified date shown below, and which would meet the minimum technical specifications required.

4.The schedule of bidding activities is herein stated below:

  - Issuance and availability of Negotiation Documents- October 03 to October 07, 2022 (8:00 AM to 5:00 PM)
  - Deadline for the Submission of Negotiation Documents (Proposal)- October 10, 2022 (10:00 AM).
- Late proposals shall not be accepted.

- b) Should submit proof of Accredited Service Center

- d) Proof of Consent from the copyright owner for the inclusions
